- 1) **Guidelines for Selection of CRCCs for Engagement:-** Only the valid applicants will be allowed to appear the written test and group discussion /Oral test. According to their achievement, the merit list will be prepared. Out of the merit list the selected list will be prepared as per the availability of vacant post of CRCC in the concerned Block. The decision of Selection Committee is final.
- 2) **Vacancy Position:** There are near about 110 nos. of post likely vacant in different Blocks of the district which are to be filled up through visioning test. However, the vacancy position may vary keeping in view of vacancy from time to time and the authority reserves the rights to take any decision for filling up of vacancy as per the field requirement. The deployment of CRCCs will be made on the basis of Merit list and subject to vacancy.
- 3) **Eligibility Criteria for Engagement of CRCCs:**
 - i. Elementary teachers Cadre Level IV/V / Zilla Parisad teachers can apply for the post of CRCC.
 - ii. The teachers against whom departmental proceedings/charges of misappropriation of fund/criminal case pending shall not be allowed.
 - iii. Teachers who have been revert back from the post of CRCC due to different reasons i.e. completion of 5 years of tenure, resignation and misconduct, administrative exigencies etc. shall not apply.
 - iv. The eligible teachers can apply for the post of CRCC only for the block , where they are working / posted.
- 4) **Placement Criteria for Engagement of CRCC :**

The selected Teachers for the post of CRCC may be engaged in the vacant clusters under the concerned block, through open counseling according to their merit.
- 5) **Documents to be Submitted:**


